ABOUT THE CONTRIBUTORS

William Bentley is the principal of Salmon Brook Associates in North Granby CT. He recently retired as Professor of Forest Policy and Management at the SUNY College of Environmental Science and Forestry, Syracuse NY, where he was Chair, Faculty of Forest and Natural Resources Management. He taught forest and natural resource economics at Michigan, Yale and other universities, managed Forestry Research for the Crown Zellerbach Corporation in the 1970s, worked for the Ford Foundation in New Delhi, India, and later was a senior program officer with Winrock International. He served as chair and facilitator of the Blue Ribbon Panel on America's Forest Research Policy. His paper with Richard Guildin draws on recent work by the US Forest Service to estimate US performance on the Montréal Process criteria and indicators.

R Albert Berry is Professor Emeritus of Economics and Research Director of the program on Latin America and the Caribbean at the University of Toronto's Center for International Studies. He holds a Ph. D. from Princeton University. His main research interests, with focus on Latin America, are labor markets and income distribution, agrarian structure, the economics of small and medium enterprise, and the economics of forests and of sustainability. Apart from his academic positions at Yale University, the University of Western Ontario and the University of Toronto, he has worked with the Ford Foundation, the Colombian Planning Commission and the World Bank. He is currently directing a research program on an employment strategy for Paraguay.

Clark S. Binkley, Managing Director and Chief Investment Officer, Hancock Natural Resource Group, is responsible for raising equity capital, client account management, and investment strategy and research functions. Prior to joining HNRG, Clark was Dean of the Faculty of Forestry at the University of British Columbia. He has served on the boards of directors of several publicly traded forest products companies and private timberland ventures and has consulted for numerous forest companies, governmental agencies and conservation groups. He has written more than 100 books and articles on forest economics, and is known worldwide for his research on timberland investment. Clark holds degrees in Applied Mathematics and Engineering from Harvard University and in Forestry and Environmental Studies from Yale University. From 1978-90, he was a member of the faculty at Yale University, both in the School of Forestry and in the School of Management, and in 1990 was named the Frederick K. Weyerhaeuser Professor of Forest Resource Management.

Cherukat Chandrasekharan holds a Ph.D. degree in Natural Resources Economics from the Michigan State University, East Lansing. He has over 50 years of experience in tropical forestry. Before joining the FAO as a forestry expert in 1975, Chandrasekharan had served in various capacities in India. During his 20 years of service in FAO, he has held several positions - Regional Forestry Economist of the

Asia Pacific Region at the FAO Regional Office in Bangkok, Forestry Institutions Specialist in Bangladesh, Team Leader of the FAO-World Bank Forestry Studies Project in Indonesia, Senior Forestry Policy and Planning Officer, Chief of the Non-wood Forest Products and Energy Branch. After retirement from FAO in 1995, Chandrasekharan has been actively engaged as a Consultant for ITTO, FAO, UNDP, ADB, CIFOR, Ford Foundation and IDRC. He is also a member of the Board of Governors of the Indian Institute of Forest Management, Bhopal. He has authored some 120 papers and publications.

Graciela Chichilnisky holds two Ph.D. degrees, Mathematics and Economics, from the University of California, Berkeley. She holds the UNESCO Chair of Mathematics and Economics and is Professor of Statistics at Columbia University. She is Director of Columbia's Center for Risk Management (CCRM) and created Columbia's Program on Information and Resources (PIR). She is a Senior Advisor to the University of Arizona Science Center. She is a recipient of the 1995 Lief Johansen Award from the University of Oslo, and has been the 1994-95 Salinbemi Professor at the University of Siena. Currently, she is Chairperson of Cross-Border Exchange, and from 1985-90, she was Chairperson and the Chief Executive Officer of FITEL. She has served as advisor to the World Bank, the United Nations Economics Commission for Latin America and the Caribbean, the Organization of Economic Cooperation and Development, the United Nations and the Organization of Petroleum Exporting Countries (OPEC). She is the author of twelve books and some 190 scientific articles. She has been the editor or the member of the editorial boards of leading professional journals, including *Advances in Applied Mathematics*, *Review of Economic Studies*, *Economic Letters*, *Journal of International Trade and Economic Development* and *Journal of Development Economics*.

Chimere M. Diaw is a senior anthropologist and rural sociologist at the Centre for International Forestry Research in Yaoundé Cameroon. During his 24-year research career, he also worked for the International Institute of Tropical Agriculture, the Dakar-based Center of Oceanographic Research, and in several international research programs on Adaptive Collaborative Management of forests, Environmental Services and Rural Livelihoods, Environmental Decentralizations, Criteria and Indicators of sustainable forest management, West African fisheries and International fishing migrations. His research works include the mathematical modeling, and most comprehensive analysis-to-date, of the share system in coastal fisheries, the economic anthropology of non-wage systems and kinship, economic theory and non-conventional economic systems, community forestry, indigenous tenure systems and common property institutions, community conservation and co-management, participatory action research and interactive social methodologies. He currently coordinates CIFOR's Governance program activities in the Congo Basin and is a member of the World Commission on Protected Areas, the IUCN Commission on Environmental, Economic, and Social Policies, and the IUCN Collaborative Management Working Group.

Alison J. Eagle is a research associate in the Resource and Environmental Economics and Policy Analysis (REPA) research group in the Department of Economics at the University of Victoria. Her research focuses on biological and economic issues related to agriculture and forestry.

Richard W. Guildin is Director, Science Policy, Planning, Inventory, and Information, with the USDA Forest Service in Washington DC. He is responsible for the Forest Inventory and Analysis (FIA) program--America's forest census. He led the team that recently completed the National Report on Sustainable Forests-2003. This report was the first to describe the condition, health, and productivity of U.S. forests in terms of the 7 criteria and 67 indicators endorsed by the 13 Montreal Process countries for reporting on the sustainability of temperate and boreal forests. Among his other responsibilities are seeking new ways to bring the latest science to policy makers to better inform decision-making, strategic planning and budgeting for the agency's research and development program, and developing information management policies that safeguard long-term research data bases and assure that research results are based on high-quality information.

William F. Hyde is a forest economist and policy analyst who taught at Duke University and Virginia Tech and served as a senior researcher with Resources for the Future and the US government's Economic Research Service. He has participated on the editorial boards of seven international economics and forestry research journals, including a term as editor of *Forest Science*, the leading international journal of forestry research. His research covers a range of forest policy and management issues: timber supply; public forest management and government regulation of private forestry; fuelwood, recreation, endangered species management; community forestry and community impacts of forestry; agroforestry; and investments in forest research. His experience includes technical observations from, and research participation in, over thirty countries. He has published more than 100 professional papers and books, including, most recently, *China's Forests: Global Lessons from Market Reforms* (co-authored and co-edited with Brian Belcher and Jintao Xu), Resources for the Future, 2003.

John Hartwick has taught at Queen's, Kingston, Ontario, since 1969. He has published in leading economics journals on urban structure and on exhaustible resources. In the 1970's he became interested in the idea of compensating the next generation for resource stock depletion by bequeathing them more produced capital, equal to the value of the current natural resource draw-down. A more general treatment of this issue is forthcoming in the *Canadian Journal of Economics*, with Kirk Hamilton. A recent pre-occupation has been the economic nature of sustained motion in classical mechanics. Capital theory turns out to be well-suited to this analysis. His work on deforestation has focused on the way a "new country" adjusts its land-use in the face of new external prices for its primary product exports.

Shashi Kant is Associate Professor of Forest Resource Economics and Management at the Faculty of Forestry, University of Toronto, Canada; he completed his Ph. D. in

Forest Resource Economics at the University of Toronto in 1996. He is a recipient of Premier's Research Excellence Award for his research on economics of sustainable forest management. His research interests include market as well as non-market signals of resource scarcity, institutional and evolutionary aspects of economics of sustainable forest management, quantum theory and behavioural economics, game theoretic and agent-based models, social choice theory and forest management. He is an Associate Editor of *Journal of Forest Economics*, and *Canadian Journal of Forest Research*. He has published more than fifty refereed papers and has worked as a consultant to the Food and Agriculture Organization (FAO), United Nations Environment Programme (UNEP), Swedish International Development Agency (SIDA), International Network for Bamboo and Rattan (INBAR), and Ontario Ministry of Natural Resources (OMNR).

M.K. (Marty) Luckert is Professor of Forest and Natural Resources, Economics and Policy, in the Department of Rural Economy, University of Alberta. He has broad experience investigating property rights to natural resources in Canada and abroad. His research has assessed how property rights influence incentives for firms to manage natural resources, and whether these incentives further the pursuit of policy objectives. Much of his work has dealt with Canadian forest tenures and subsistence economies in southern Africa.

Harry Nelson is a Senior Research Associate at the Forest Economics and Policy Analysis Unit of the University of British Columbia. Dr. Nelson has written about and conducted research on the interaction between international trade and forest management, as well as other topics such as the nature of competition in wood product markets, the Canada-US softwood lumber dispute, and the economic impacts of pollution upon the Canadian forest sector. He has also prepared studies for forest product companies, First Nations, the Federal government, and provincial governments, and has degrees from the Kennedy School and the University of British Columbia.

Roger A. Sedjo is a Senior Fellow and the Director of the Forest Economics and Policy Program at Resources for the Future (RFF), and the President of the Environmental Literacy Council (ELC). He has authored or edited fourteen books related to forestry, natural resources and the environment. His work focuses on both commercial timber industry issues such as timber supply, forest plantation and biotechnology in forestry, as well as on the conservation and environmental aspects of forests. He edited a recent book, *A Vision for the US Forest Service* (2000), on Forest Service issues and future potentials. Other recent books include *Sustainability in Temperate Forests* (1998), with A. Goetzl and S.O. Moffat, and the *Economics of Forestry*. Other important books on the forestry and timber supply include *The Long-Term Adequacy of World Timber Supply* (1990) and *The Comparative Economics of Plantation Forestry* (1983).

G. Cornelis van Kooten is a Professor of Economics and Canada Research Chair in Environmental Studies and Climate in the Department of Economics at the

University of Victoria in Canada. He also holds a courtesy appointment in the Agricultural and Rural Policy Group at Wageningen University in the Netherlands. He has published more than 100 refereed journal articles in agricultural, forest and natural resource economics, and eight books, including *Climate Change Economics* (2004), *Forest and Land Economics* (2004) with Henk Folmer, and *The Economics of Nature* (2000) with Erwin Bulte.

Arild Vatn is a Professor in Environmental Sciences at the Department of Economics and Resource management, Agricultural University of Norway (AUN). His research is focused on institutional aspects of environmental resource management. His theoretical work has centered on issues concerning human motivation, the formulation of policy measures, choice of resource regimes and environmental valuation. His empirical work concerns analyses of different resource problems ranging from agricultural pollution to biodiversity protection to various regime issues. He has been head of several interdisciplinary research programs both at AUN and the Norwegian Research Council. Presently he is leading the program 'Environment and food production' at AUN. He is also leading a research team working on biodiversity protection in forests. He is vice president of the European Association of Ecological Economics. He has authored approximately 100 papers, books and scientific reports. He has just finished a book titled *Institutions and the Environment*, which will be published by Edward Elgar in 2005.

Ilan Vertinsky: Dr. Ilan Vertinsky is the Director of the Forest Economics and Policy Analysis (FEPA) Research Unit. He is also the Director of the Center for International Business Studies and the W. Maurice Young Entrepreneurship and Venture Capital Research center at the University of British Columbia. His major research interests are: international trade and competitiveness issues, innovation and forest sector business strategies. Currently, in collaboration with a team of researchers from across Canada, he is investigating new designs of tenure systems and their potential impact on sustainable forest development. Ilan has published more than 230 journal articles, book chapters, monographs and books on diverse topics including economics, operation research and animal ecology.
